Megan Close Zavala Helps Writers Follow Their Dreams

El Segundo's Megan Close Zavala is an avid reader and five-year entrepreneur. She has figured out a way to not only satisfy her love of prose but make money at the same time. Not a bad gig, right, getting paid for something that you would probably pay to do?

Zavala, the founder and owner of Turn the Page Book and Editorial Coaching, gets paid to read, edit, and advise on other people's creations.

Zavala grew up in Silver Spring, Maryland, in what she termed "a book-filled home." She said that both of her parents were "incredibly well-read," mentioning that her father was a "voracious reader." She remembers that growing up, if she posed a question to her father, his stock answer was, "We've got a book on that!" She said that "storytelling has always been a huge part of my life, whether book-related or film-related."

Zavala graduated from the University of Hartford, then sojourned to environs nearby to Tinseltown to chase her dream. She said she was "obsessed with films my whole life" and was "determined to become an Oscarwinning screenwriter," a lofty career goal. She spent a short time as a personal assistant for a producer, also later working in the business and legal affairs department at the E! network.

After toiling in the entertainment industry for most of her 20's, Zavala said that "I realized that the entertainment industry was not where I was destined to be and started looking for my new path."

And that "new path" exploration was jumpstarted when she met her later-to-be husband Mike while both were living in a Burbank apartment complex. Zavala said that the landlord played matchmaker, and after a few months of dating, Megan and Mike Zavala moved to India, where Mike had been offered a job. The couple spent a year in India and, when returning stateside, got married, and now have two children. While in India, the couple traveled all over southeast Asia, and Zavala said that she started focusing on her editorial work. She landed a job as an editorial assistant at a literary agency, quickly becoming an agent. She loved her work, Zavala said, but soon realized that because "agenting is 100% commissioned based, I couldn't afford to work with clients who weren't 100% ready to publish and 100% likely to sell." So, she switched gears, started her own editorial services company, and "I haven't looked back. I truly love what I do."

Mike Zavala works in the film industry as a visual effects producer. With many of his jobs centered on the Westside, the Zavala's

Your Neighborhood Therapist

Dear Neighborhood Therapist,

I have been a perfectionist my whole life. It has always been a struggle for me but I have been able to handle it. Now I feel like it is too much and I want to let go of it. Is there anything I can do? It feels like I would have to change my personality, and I'm not sure I can do that, or want to do that.

- Perfectly Miserable, El Segundo

Dear Perfectly Miserable,

We celebrate perfect - in sports, like gymnastics and baseball - but also countless other aspects of our lives. Pundits breathlessly hail a "perfect" speech and Instagram lights up at a meal "perfectly" prepared. The list goes on. We are a perfection-loving society.

No wonder you're feeling miserable: while we celebrate "perfection," we are also quick to jump on mistakes. In the same way that it is so much easier to tear something down than it is to build it up, it is much easier to notice flaws than it is to appreciate the effort and skill that goes into any creation, perfect or not.

I have a few questions and thought experiments that should get you started in considering your next steps.

First, what is perfectionism, to you? When I think about what we commonly consider to be "perfectionism," I imagine a wide range of possible definitions, for example: a strong dedication to doing the best possible work in a particular craft; feeling intense anxiety because everything you do will harshly scrutinized and judged by others; a sense of knowing what good work is, and that you could always do just a little bit better. But that's me. When you think about perfectionism as it applies to your life, how would you define it?

Next, what if you think about perfectionism as something - or better yet, someone - you live with, rather than who you are? If you have lived with perfectionism your whole life, it does not seem reasonable to expect that such an old acquaintance will go easily into the night; nor do I think that the total extinction of perfectionism should necessarily be your goal. Is it possible that Perfectionism - let's go ahead and give him a capital P for a proper name - has been beneficial to you in some ways?

More importantly, how would you describe the voices of Perfectionism? Who are these voices and what supports them? We already mentioned the voices of Perfectionism we are all exposed to when we participate in society. Is Perfectionism's voice also (I am using the metaphor of a voice but you may prefer a different one) that of an unreasonably demanding parent or teacher or authority figure? Perhaps it is the voice of a friend, or partner, or a childhood bully. The old "know your enemies" adage applies: the better you know the problem, the more effectively you will be able to confront it.

This is not easy, but once you start the process of scrutinizing Perfectionism - turning the tables, you might say - the paths forward may very well begin to reveal themselves.

In Dancing With the Devil, Demi Lovato Reinvents Herself as a Confident, Queer Woman

If the opening night showcase film at this year's SXSW film festival set out to prove anything, it's that sharing our struggles with strangers can be a cathartic and positivelyaffirming experience. When you're former Disney star/recovering addict/and newly "out" artist Demi Lovato, it can also be quite vulnerable and scary.

Drawing comparisons to the recent New York Times-produced documentary Framing Britney, which revealed a troubling, unacknowledged history of one of the world's most famous pop stars (Britney Spears),

Directed by Michael D. Ratner, Dancing with the Devil joins the ranks of other docs made by former young pop culture icons who want to tell (and own) their stories, including Justin Bieber: Seasons and This is Paris. While Dancing with the Devil is itself, an engaging work, it feels as though its purpose is a thinly veiled beg for forgiveness from her peers and fans. I don't feel like it's my place to judge someone's past and their explanation as to why they did certain things, but the audience's only requirement here is to sit and listen. Demi's hope is that we allow her the chance for a fresh start,

Demi Lovato's own story-Dancing with the Devil, now streaming on YouTube-sounds hauntingly similar.

Demi's catapult to stardom first launched as a child in Barney & Friends, then Disney Channel, and quickly led to deep-rooted insecurities, teenage rebellion, and addictions of many kinds. Demi candidly talks about her eating disorders, losing her virginity as a teenager in a sexual assault, and her tumultuous relationship with drugs and alcohol; it's the last topic that is covered most in-depth, and serves as the genesis behind making this film.

Dancing with the Devil shows that this wasn't Demi's first attempt at shooting a documentary to show her struggles. In fact, the initial shoot shut down in 2018 after Demi suffered a near-fatal overdose in which, as she reveals now in the doc, she was mere minutes away from dying. Removing herself from the public eye for a few years to recharge and reset (as well as rest her voice), Demi attributes 2020's forced quarantine with her family and ex-fiancé to keeping her alive. For many, 2020 was a brutal year; but as her family and close friends share in the film, it was the best thing that could have happened to Demi.

and this is her explanation as to why she deserves one.

So, the big question: is the struggle over for Demi Lovato? The film doesn't leave us with a confident answer either way, but one thing it hammers home is that the Demi who is going to reemerge in 2021 is not the same woman we've seen before. This new woman has the power to come out on top, and we should all be rooting for her muchdeserved comeback.

Seasons Start for Eagles

Finally, after over four hundred days since the El Segundo high school football team played their last game, they played their first game. The baseball team's wait to play was a mere 375 days since their last game. Both teams embraced their season openers with anticipation, a little nervousness, and plenty of zeal for their favorite sport. The results weren't favorable in either team's opener, but both head coaches weren't too concerned for the loss.

Coach Green Finds Positives in Football Loss

First-year head coach Shawn Green's debut, went as positive as it could have when you sum up all that his team had to face. First, they were on the road playing at South Torrance High, which is notorious for its brisk evenings and strong cold winds. The Eagles were facing a team that had won a CIF Championship and had a number of starting returnees from that team. Finally, Coach Green's team had a limited number of days to prepare for what amounts to a five-game season.

The Eagles were prepared and played well, but mistakes overtook them at times, and they fell 21-8.

The South Torrance Spartans had some key returnees from their CIF title run, including Kade Jones. Jones was converted from receiver to quarterback this season. He scrambled for 97 yards and three touchdowns while completing 5-7 passes for 37 yards.

The Spartans took advantage of two firstquarter Eagle mistakes in the first quarter to take a 14-0 lead. El Segundo opened the game with a long drive that ended with an interception. The Spartans reversed the field and scored n a 22-yard run by Jones. On the Eagle's next possession, a muffed snap gave the Spartans the ball at the El Segundo 1-yard line. Two plays later, Jones scored again. The Spartans took a 21-0 lead midway through the second quarter on another long run by Jones.

El Segundo's offense kicked in and drove to the South Torrance 2-yard line. Junior quarterback Conor Hochberg then ran it in for the score. He connected with James Pearson for the two-point conversion to make it 21-8. The second half saw the two teams fighting the elements but came up empty on the scoreboard.

It was a typical first game with plenty of mistakes and plenty of positives to build on. The offensive line played solid, the defense played with a passion, but the execution on some plays showed a lapse. Coach Green was subdued and positive afterward, knowing this is just the start of his coaching career. "They played with energy, and they fought

hard, and that's my number one take away from this game, Green said.

The Eagles travel to North Torrance Friday at 7 p.m. to face a good Saxon team. The Eagles home opener is next Friday at 7 p.m.

Stolnack Helps Ignite Win with Homerun

The El Segundo baseball team started play in the 53rd Stevenson/El Segundo Tournament and split their first two games. In the season opener, the Eagles fell 4-1 to the Palos Verdes Sea Kings and then turned around to defeat Long Beach Wilson 8-7 in ten innings.

In the opener, Brendan McAndrews singled and later scored on Julian Rodriquez's double in the first inning to give the Eagles a 1-0 lead. It would be the only runs El Segundo would score, but it wasn't for the lack of opportunities. The Eagles wound up leaving ten runners on base, including five in scoring position. The Sea Kings sent six different pitchers to the mound to stop the Eagles, who had six hits.

The Sea Kings tied the game in the third inning when Jayden Camel singled and scored on Gavin Peters' RBI single to make it 1-1. In the fifth, Peters reached on an error and later scored on Christos Tsangaris' RBI single. P.V. scored two more in the sixth on Will Mashy's two-run single to make it 4-1.

El Segundo faced the LB Wilson Bruins in the second game that stretched into the ten innings that spanned over three hours. In the end, it was poor fielding on the Bruins part

began to purchase items, putting them on layaway to reserve them for himself.

"One day [the shop owner] said to me, 'You've got like twenty things on layaway, when are you going to pay for them?" says Martin. After a couple of beers and some lighthearted discussion, the shop owner asked him if he'd just buy the shop. So Laurence did. This purchase became Studio Antiques, named for its predecessor.

While he handles most of the buying and packaging, Sally, his wife, handles more of the business side of things, a complement to each other. While working a 9 to 5 corporate job, she began helping out with the business on the weekends, which eventually turned into her full-time gig. With her master's degree and organization skills, she most often runs the shop daily, makes friends with customers, and keeps the books in check.

"I needed a secretary, and Sally fit the bill," jokes Laurence, immediately rebuked by Sally.

"He only says that at the right moment because he knows it makes me angry," she laughs.


Both of them are avid historians. Their extensive experience, along with the help of friends, who are experts in the field, allows them to provide appraisals as part of their services and helps them get valuable items for their shop, which also operates online.

A myriad of odd, eclectic, and valuable items have passed through their collection, from a rare pressing of a Beatles album released on their first trip to America for the Ed Sullivan show, to a memo sent out by John Adams suggesting that Washington's birthday should be made a national holiday (of which there are only five known copies in the world).

These days, while antiques are still the name of their game, they've had a mass customer interest in vinyls.

"I'll tell you, this is my personal opinion," says Sally to explain the recent resurgence of vinyl enthusiasts, "In the late 1800s, there was a movement called the Arts and Crafts movement, and it was a reaction to the industrial revolution." She goes on to explain that this movement was an artisan rebuttal to factory lines and automated jobs. People began hand-making and designing interiors and items amid the availability of mass-produced consumer products.

"Well, I think in this century, everything is digital, and you don't have to have anything physical," she says, saying that she believes

there is a surge in vinyl sales "because now you can hold something. You can read the liner notes. You can play it from beginning to end." In addition, listening to an entire album is often an event to be done together with others, something we've had very little of in the last year.

After thirty-three years in business, they say their inventory has come from all over. Laurence used to travel to places like France, Australia, and China and buy items to be shipped back to the shop for stock. They scour estate sales, get calls about lots, and look in unclaimed baggage. Also, since landing their reality shows, they have customers come in from all over and donate items, get appraisals, or list their items on eBay through them. By being close to the airport, their customer base is a global community.

Something the couple is very attuned to is family sensitivity. Often, items are donated to them after the loss of a family member or an elderly family has moved into assisted living and needs to downsize.

"We deal with a lot of people who are experiencing loss, especially right now, and it's something that we try to be sensitive about, too," says Laurence. They appreciate all their items greatly, and even if they don't want an item for their stock, they help give advice on finding it the right home.

"You might think this is strange, but I'm a little bit psychic," he says, "and some of the customers who pass on... I think they're up there, and they direct their family to bring this stuff to us because they know that we're gonna be really fair."

Currently, they run their show called "Around the Bend" on YouTube, interviewing interesting subjects and talking about antiques. In the back of their shop, they have what they affectionately call the Ghost Town. It's a series of sheds constructed from reclaimed wood that used to comprise an 1860s cabin in Big Bear. As things open back up, they are looking to the future and hoping to hold small concert events with their vinyls in the Ghost Town to bring the community together and talk about old things with new friends. •

looked for digs a bit closer to where the jobs were to lessen the crummy L.A. commute. Mike suggested that they explore finding a place in El Segundo. Megan, being the East-coaster, did not know much about El Segundo, other than it was the home of the Mattel headquarters and was located south of LAX. She remembers thinking: "Why would we move by the airport? I don't understand?"

Zavala has not regretted relocating to El Segundo, a city she calls "a magical place, a hidden gem," where their family has added two young children to the mix. "We love it here so much."

Throughout her career, Zavala has worked for and with many creative and talented people, including top literary agent Wendy Keller,

Keller, who Zavala cites as her publishing mentor and former boss in the literary agent world, emailed that "Sometimes, you meet someone in one context, and it burgeons into a friendship. When Megan and I first started working together in my office in Marina del Rey, I could tell right away that she was unusually smart and easy to get along with. What I did not expect was for her to become someone I care about so much! Over pizza "staff lunches" with just the two of us - we got to know one another, and I heard about her romance with Mike, the man who is now her husband. I even got invited to the wedding! When she was pregnant with her first child, we would laugh that we were planning to set up a bassinette in our small office so that we could tend the baby and still work side by side. We have kept up our friendship and a new iteration of our work together all these years. I consider Megan an incredibly dear, kind-hearted, competent and intelligent woman."

"When Megan came to work with me, she was already knowledgeable about screenplays and books. She had a broad interest in the publishing industry. My company specializes in selling only nonfiction books, usually to major US publishers - Simon and Schuster, HarperCollins, Penguin Random House, etc. This was a different part of the business than Megan had worked in before. Her adaptation was incredibly quick! She not only completed the things mandated by her job, but rapidly understood how those tasks connected to the whole and began filling in gaps I didn't even know were there!"

Zavala has developed a stable of satisfied clients over the past few years.

Rob Sullivan is one of Zavala's editorial/ coaching clients. When he was casting about, searching for someone to help with his manuscript, he found Zavala. "I always trust my intuition," Sullivan said. "There is something about her; I wanted to work with her." Zavala helped Sullivan put together his manuscript proposal. He noted two facets of Zavala's work that stand out. "She (was) very honest," he said when she evaluated his manuscript proposal, as well as edit the manuscript.

"The thing that I love about her the most is how open she was and helping me to add other people's stories to my book," which, Sullivan said, was able to give validity to some of his book chapters.

Another Zavala client, Joel B., has worked with Zavala for four years. "I worked with Megan on a book I wrote about digital marketing," he emailed. "I developed a work plan and had Megan review each chapter and provide feedback along the way. She also conducted a full review of the manuscript before I submitted it to my publisher. Zavala said that Ben Larracey is another of her editorial/coaching clients and has been familiar with her work "from my very early entertainment industry days." Emailed Larracey: "I first met Megan in 2006 when we were both interns at Kopelson Entertainment.

"Meg and I read and wrote coverage on screenplays that came in. This company had walls of scripts that needed to be read—like thousands. So, we would read scripts and see if it (they were) right for the company.

"Meg knows scripts and stories inside out: the beats, character movements, overall plot. She is great at it. Probably seen a million movies and read even more books."

Anjanette Fennell is also a Zavala client, as well as a fellow book coach editor. "Over the years," Fennell emailed, "she has helped as a trusted friend and colleague in what can sometimes feel like a crazy industry (publishing). As an independent agent and coach, I can often feel alone in business, and it is our regular chats about life and all things literary that help me get clarity and connection. Of course, she has also become the first person I think of when wanting an insightful, considered and

thorough editor."

Not surprisingly, when Zavala is not getting paid to read, she enjoys reading for pleasure, especially mysteries and thrillers, and said that she regards the novel Prince of Tides written by Pat Conroy as her favorite book. Zavala's other favorite authors include James Ellroy, Jane Harper, and Tana French.

An avid film buff, Zavala, like many of the rest of us, is looking forward to the time when she can enjoy the full movie-going experience in theatres again. She cited the Harrison Ford vehicle The Fugitive as well as the brilliant 1976 dark, satirical comedy-drama Network, written by Paddy Chayefsky, as two of her all-time favorite films.

Zavala said that the best part of her job is "getting to read for a living, and helping people achieve their dreams." On the flip side, Zavala says it can sometimes be challenging when a client "doesn't take my advice" while moving through the writing and publishing process, even though the client has presumably hired Zavala to tap into her literary expertise.

All in all, no complaints, Zavala said. "I can live in a world of books for fun and work...I am so grateful!"


